Banco Montepio informa sobre alteração às Condições Finais das Obrigações Cobertas com o ISIN PTCMGEOE0034

A Caixa Económica Montepio Geral, caixa económica bancária, S.A. (doravante **«Banco Montepio»**) tem um programa de obrigações cobertas constituído ao abrigo do Regime Jurídico das Obrigações Cobertas aprovado conforme previsto no artigo 2.º do Decreto-Lei n.º 31/2022, de 6 de maio (doravante **«Programa»**). O Programa foi aprovado no formato *Conditional Pass-Through*, com uma extensão automática do vencimento das obrigações cobertas para uma data futura pré-determinada caso se verifiquem certos eventos (os denominados *Issuer Events*), conforme previsto no prospeto base do Programa (doravante **«Prospeto»**) atualmente em vigor, aprovado no dia 20 de julho de 2023.

O Banco Montepio informa que as obrigações da emissão com o código ISIN PTCMGEOE0034 se encontram integralmente retidas no seu balanço e que, na qualidade de obrigacionista único, deliberou unanimemente por escrito (*Written Resolution*) a alteração da data de maturidade (*Maturity Date*) de 9 de novembro de 2023 para 11 de novembro de 2024, mantendo-se inalterados os restantes termos e condições das Condições Finais (*Final Terms*) da emissão.

A alteração da data de maturidade agora promovida não constitui uma extensão automática do vencimento conforme previsto no Artigo 21º do Decreto-Lei N.º 31/2022, sendo antes uma deliberação tomada pelo Banco Montepio enquanto obrigacionista único, conforme definido na condição 12 (*Meetings Of Holders Of Covered Bonds*) dos *Terms And Conditions Of The Covered Bonds* do Prospeto.

Incluímos em anexo ao presente comunicado as Condições Finais (*Final Terms*) atualizadas conforme deliberado unanimemente por escrito.
